BUSINESS - WORKSHOP ITEMS:

1. Consideration and **ACTION** to direct City Engineer, 6S Engineering to proceed with the preliminary engineering and additional professional services in the amount not to exceed \$100,384 for the reconstruction of Hillcrest Drive and submission of a grant application to the Alamo Area Metropolitan Planning Organization (AAMPO) for the October 2020 Call for Projects.
2. Consideration and **ACTION** to enter into a construction agreement with SAECO Electric & Utility, LTD for the upgrades for the traffic signal at the intersection of Hillcrest Drive and Babcock Rd. and revised budget project.

3. Consideration and **ACTION** to enter into a construction agreement with EZ BEL Construction, LLC for the Vivian Lane Street Reconstruction Project including Add Alternative No. 1 or No. 2 for the addition of parking spaces at Rogier’s Park and revised budget project.
4. Consideration and **ACTION** to award a contract for the remodeling of the Justice Center in response to the COVID pandemic and approve budget project.
5. CARES Act grant—Approve grant project budget.
